Although professional staff, board members, and volunteers will always have personal relationships, they should be aware that such relationships must not imply favoritism to particular agencies, businesses, organizations, or other community groups when conducting business.

The employees, board members, and volunteers may not use their position with the Greeley Transitional House to access or influence outside community services without meeting the same requirements and procedures set by the outside community services.

If it is determined that there is indeed a conflict of interest, the board member, employee or volunteer will be excused from participation in any activity or discussion of the item and may not vote on the item.

It is the responsibility of each employee to report to the Executive Director any concern as to the propriety of a given relationship. If at any time the employee is discovered in such a conflict of interest situation, the Executive Director will review the situation. Depending upon the severity of the conflict, the employee may be subject to disciplinary action up to and including dismissal.
